# SUPERINTENDENT'S REPORT

#### **Extended School Year**

Dr. Halliman reported that we have a total enrollment of 208 students in our Extended School Year (ESY) Program. The Early Learning Center (ELC) program has 92 students, the Program for Adaptative Learning (PAL) program has 80 students, in the Independence program there are 20 students and the Academy for Lifelong Learning transition program (ALL) there are 16 students.

The theme this year is "Summer in Bloom" which is in keeping with our theme this year of "Blooming with Grace, The Seeds You Plant Matter!" All throughout the district there are butterflies in the stages of blooming and being released, planting and pruning is everywhere. We are up and away for the summer.
