AUDIENCE TO VISITORS

Bridget Reed, DHH Itinerant, worked for Speed for 31 years. She stated that she is the Grievance Chair for Speed. She asked for the support of the Board. The staff is low and is hurting. We have so many good teachers that are 39 positions. ELC has two certified staff helping 5 teachers that are 39s. They are helping but it's a tremendous amount of work. They do receive an hour of pay daily but it doesn't balance the scale, nor does it benefit the kids. We have an opening in DHH. We had a great candidate. Dr. Hill can confirm this, but a sister coop gave her \$12k more. This is a great place to work, and we want to keep it going. Your support in helping our staff get the money they deserve, and a fair insurance rate would be great.

Steve Zomparelli, Occupational Therapist at PAL. He shared it's a pleasure working here. His main concern as well as that of a lot of employees that have families is that the insurance cost is so high. The percentage that we have to pay which is 48%/52%, compared to other districts that's a big gap. Other districts pay 70/30, 85/15 but 48% is very hard. HMO is \$1000. If we could rectify and get the benefits package better, we could draw in more people to want to work here. Right now, there are a lot of places that offer better benefits.

Ms. Vlietstra thanked both of the employees for their comments stating that all of their recommendations are noted. She stated that Dr. Halliman and her team will do their best.
